Payment and Cancellation Policy

The Agency offers guests a choice between two payment and cancellation policies.

Non-refundable Rate

Guests who choose the non-refundable rate are entitled to a 5% discount on the total accommodation price. Under this rate, 100% of the total reservation amount is charged at the time of booking confirmation.

In case of cancellation, modification, or no-show, no refund will be granted, regardless of the reason for cancellation.

Standard Rate – Payment Before Arrival

Guests may choose the standard rate with the obligation to pay 100% of the total reservation amount no later than 30 days before arrival, or 60 days before arrival for selected properties, depending on the accommodation conditions.

After the deadline of 30 days, or 60 days before the start of the reservation, no refund will be granted in the event of cancellation, modification, or no-show.

In both cases, the reservation is considered valid only after 100% of the total reservation amount has been charged, in accordance with the selected payment policy.
